INTRODUCTION:

The Muslim Ambulance Society is a premier organization, which was established in the year 1932, rendering humanitarian and medical welfare services to poor and needy people without distinction of caste, creed and religion for the past 92 years. The Society is registered under Bombay Public Trust Act, 1950 and also under Societies Registration Act, XXI of 1860, engaged in various Medical and Charitable activities involving Diagnostic Centre, Maternity and General Hospital as well as Child Care Hospital.

- The Society runs **Ambulance and Hearse vans** round the clock 24 hours throughout the year.
- It is also managing **free Immunization centre**.
- The Society had also conducted free Tuberculosis Centre for more than 50 years, where full course of free medicines including 2nd line of treatment were given to the poor & needy patients suffering from this dreaded disease.

In March 1988, the society took a big step by starting '**THE MUSLIM AMBULANCE SOCIETY DIAGNOSTIC CENTRE**' at 141, Zakaria Masjid Street, Mumbai – 400 009 for conducting various investigations at very reasonable and affordable charges. It is heartening to note that since its inception 34 years ago, the Centre has been making continuous and steady progress. Our charges are significantly less than what are charged at other established and reputed centres and hospitals without comprising on the quality in any way. At present we are offering all routine and specialized services of **Pathology, Radiology, Sonography, ECG, 2D Echocardiography Color Doppler examination, Endoscopic examinations, etc and alleviating sufferings of patients of Chronic Renal failure by offering Haemodialysis.**



M.H.SABOO SIDDIQUE MATERNITY & GENERAL HOSPITAL

IN THE YEAR 2004 the Mumbai Municipal Corporation gave us the building of their **M. H. Saboo Siddique Maternity Home** at Imamwada to run Maternity and General Hospital. This five- storeyed building, having 2 lifts and a spacious surrounding was then reconstructed and upgraded by us into 110-bedded hospital.

This hospital is also having **three** operation theatres, equipped with all the modern gadgets to take care of all kind of surgeries. We operate more than 400 cases per month including major & supra-major surgeries at our Operation theatres. Besides this the hospital is having **Out Patient Departments** of various specialties and **Male, Female** and **Pediatric** wards. The other notable departments are **fully equipped I.C.U. (12-bedded), N.I.C.U., and Labour wards.** We are also also providing **C.T. Scan** and **M.R.I.** facilities at this hospital on State-of-art and latest machines at less than half the charges compared to other such centres.

Apart from above mentioned services hospital is having well –equipped **Pathology, Radiology, Sonography, ECG, 2D Echocardiography Color Doppler examination, Dialysis Unit, Endoscopic examinations, etc**

Dialysis Unit consists of 26 (plus 4 machines at our hospital) new, imported and latest machines (which is the largest number of dialysis machines in our centre in Mumbai).

- ▶ We run 3-4 shifts of four hours each on each machine.
- ▶ At our Centres we dialyse more than 2000 patients per month, which is perhaps the highest in the whole of the country.
- ▶ At our Dialysis Centre we get patients not only from Mumbai and its Suburbs but also from various parts of Maharashtra and even other parts of the country.
- ▶ This service and all other facilities rendered by us are open to all classes of people without distinction of caste, creed and religion.

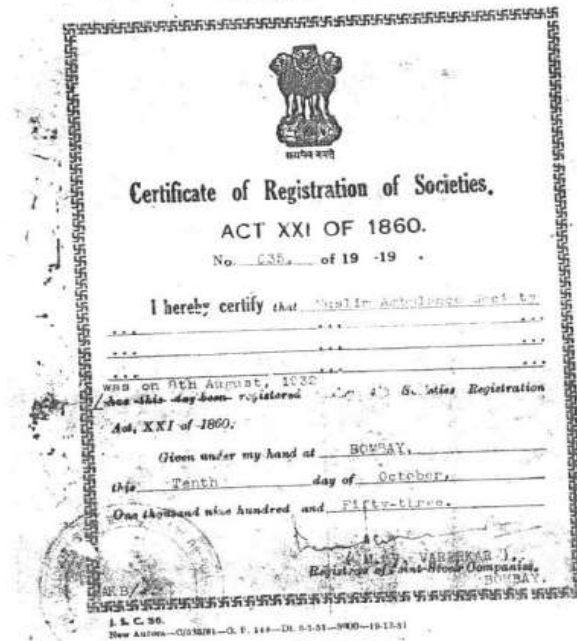
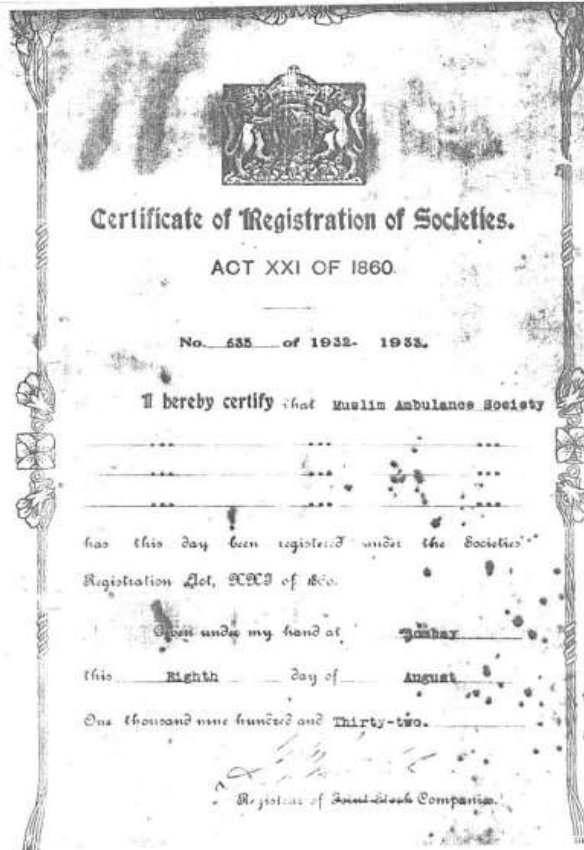
